Executive summaries for the above are attached to this letter.

Child B June 2011 – Jan 2012

Executive and full report for the above are attached to this letter.

Child JK was completed Oct 2007 – March 2008, but there is no executive summary, only a report and therefore they cannot share this as it was produced prior to guidance on publishing full reports.

They do not have any other electronic records of Serious Case Reviews or part 8 reviews prior to 2007. They are not in a position at the moment to advise if there were any completed prior to 2007 as these would be paper only and in paper archives. They will complete further work to try and identify if reports have been completed. It is possible that if the reports are in the paper archives then it would be more than 18 hours' work to locate them and scan.
