I would be content that this covers the majority of funds commissioned by HSCB for C&V organisations. I had meant to say in my earlier email that this excludes Surestart & Bright Start funding which is Dept of Education funding provided via HSCB for allocation.

In respect of the 'recurring or non-recurring' point, the request was whether the 'service is recurring or non recurring'. Part of the difficulty is that while these will represent the current service contract commitments, many of them are for a defined contractual period and so in moving forward it may well be the case that following evaluation of a particular contract it could be decided to change the service specification. In turn this may potentially mean a change in provider. Also as advised there are also some non recurrent funding elements against some service descriptions as they reflect in year contract variations. We have, as best we can, made additional comments on the return where non recurrent elements are included.

Please find attached information in respect of the above FOI for your consideration.

Some points to note:

- Generally the information has been extracted from the finance Voluntary & Community database supplemented by information from specific LCG arrangements as well as ring-fenced funding (EYDF,EIPT, Edges) where these could be readily identified.
- Most of the values are the relevant in year budgeted/commissioned amounts for services albeit there are some exceptions (for example, Grants made to various providers).
- Some may include recurrent and non recurrent elements (to include contract variations, confidence & supply (C&S) transformation funding etc)
- Service Descriptions are the most recent.

Please note that collating this information has involved significant staff resource and I would emphasise that the attached reflects best efforts to include all relevant Voluntary & Community providers.
