1.1 Adults and Children's Services

- London Borough of Ealing (LBE) has a shared emergency social care out of hours duty service with another borough.
- LBE works with other London Boroughs via the WLA on an efficiency programme relating to public health, looked after children, transport and SEN.

Service delivery

- There is an integrated operational service for children with additional needs comprising education, social care and specialist child health
- There is an multi disciplinary early intervention service comprising social care and family workers and mental health workers, for families in need of early help
- There are children's centre linked social workers and health visitors
- There is a "one front door" to children's social care and early intervention services that includes a health visitor
- The healthy schools team works closely with school nursing

Joint processes

- There is a multi agency approach to all aspects of safeguarding
- There are processes for deciding on joint funding of placements for children
- There is a common assessment framework process including a team around the family approach

There is a Children and Young People's Plan
