Request:

Could I have the follow documents/drawings for the "Sleaford Highway Improvements":

- 1. Proposed drawings of the lane/road layout for both junctions. Including road markings.
- 2. Proposed drawings of the kerb realignments for both junctions, if any.
- 3. Proposed positions of road signage (both new & retained)
- 4. Proposed drawings of new directional signs, preferably with additional information such as the x-height, surface area, visibility distance
- 5. Proposed TROs as a result of this scheme
- 6. Proposed phasing of new traffic signals. Please include the sequence, timings and triggers. Along with supporting documentation of said phasing
- 7. Document (s) regarding the safety of the improvements, including potentially detrimental effects to other junctions within the local area
- 8. Financial documents showing breakdown of cost, ideally being able to identify the costs for consultation, design, construction, maintained for each of the junctions.
- 9. Any documents or summary of other options considered for either, both, or other junctions.
- 10. Finally, will there be any changes to road classifications or primary route status as a result of this project, if so, please state what will change.
