I've copied the Clerk, and Kent officers into this and hopefully they can check this for me. My understanding is there is the equivalent of a statute of limitations which means that after a period of (I think) five years of not working with a persons / an institution, Ian can be deemed to be independent of the school and these particular governors. Since Jane Robinson was previously a Head in Kent when Ian worked in Kent, the same issue pertains. However, the relationship was not a direct one as far as I can see and there has been no contact for as long as Jane has worked at Langton.

Dear Ian,

I have now consulted with all the governors (except staff governors) on the information available to me about how long the break with previous employment / association with individuals involved in that employment should be to ensure independence. I copied this information to you also (I think!). The governors are happy to accept that due diligence has been exercised and that 3 years is sufficient to establish independence. In your case, the time lapse is much more. Though I haven't heard back from Keith, I think we've done everything we reasonably can be expected to do, and so I want to confirm that, on behalf of the Governing Body, I would like to commission you to carry out the independent investigation into the various complaints concerning SLGGS.

I also want to provide you with some additional documentation which may be relevant to your work. Firstly, I am sending you the collated responses to the consultation. I am providing the original documentation but I am also making it available in a different form found in 2 attached documents. One of these contains positive and supportive responses, and the other includes the unsupportive responses. Where a response has an asterisk, then it is included in both documents because it is less easy to categorise. I am also sending you the minutes of the meeting with staff.* Finally, I am sending you undated copies of letters to parents which were removed from the website.

Dear Parents

I am sending you a further letter on behalf of the governing body to alert you to some concerns that governors have about recent events.

It has come to our attention that some individuals, who have not yet been identified, have set up an event page on Facebook to which they have invited many of our students, requesting that they meet on school premises for a 'peaceful protest' on May 9th. Apparently, the intention is to 'force Mrs Robinson to discuss the MAT application publicly', and local media have apparently been invited. Several of our students have come to us with this news, and they are really upset and quite angry that this should have been proposed, particularly at a time when the examination classes are in the final stages of preparing for their exams and have enough stress in their lives without any distractions such as this. Many of our students are also expressing anger at how the small minority of parents on Facebook are 'whipping things up' in their words, and they believe that the majority of students have had enough of their school and governors being endlessly criticised.

The Governors wish to make you aware that your daughter or son may have received this invitation and you may be unaware. They wish to point out that there are legalities in place here, and it is not lawful for any individuals or groups to arrange such a meeting on school premises without permission of the school, which of course would not be granted. It is an unfair lobbying process which would impede the progress of the school and students at a very important point in their lives.

It has also been brought to our attention that some students in year 8 have received a tweet from a parent who also has a child in year 8, requesting them to support the campaign against the MAT process. This is being treated very seriously as harassment as it is worrying to our younger students in particular and we would urge all parents to report any such issues to the school. This parent should not be putting your daughters in such a position and it is entirely inappropriate.

Some parents have been contacting us over the past week in particular to express their shock and distaste at what is being circulated on Facebook, one stating that she thought that 'these people are causing more damage to the reputation of the school than becoming an academy ever could'. To come in this morning to find stickers in several of the corridors with such comments as 'Robinson hates grammar schools — don't let her ruin Langton', 'Don't let the Gestapo silence us', 'Spires can sort out its own problems' are deeply shocking and upsetting, most particularly when our students do not behave in such a way, and have been set up to do this by a very few parents who should know better.

Yet again, I have been asked to encourage as many of you as possible to respond to the governors' consultation about academy status — if you are supportive or still have further concerns. The governors will consider all responses and these will influence their decision about whether to proceed to the next steps. We have also placed more information from other Headteachers in the area who are involved in multi-academy trusts, which I hope you will find the time to read over the weekend.

Dear Parents

I am sending you another letter with even more information about academy and MAT status, as we have had further questions from some parents. Some of you may have received a leaflet during Year 7 Parents' Evening last Wednesday which identified a number of points which I would like to clarify:

- There is no rush for our school to become an academy or MAT. This is not a forced decision and it is not yet a definite decision. We are in a consultation process and all stakeholders have been asked to give their views over a period of 8 weeks (the minimum period should be 4 weeks, and the norm is between 4 6 weeks).
- The completion of this process is May 16 (not the 1st week of June) after which all responses will be considered by the Governing Body, before making a definite decision.
- The final signing of the funding agreement with the EFA is the time at which the decision is irrevocable (not 1st June).
- SLGGS is not being 'forced to join a MAT', the school's GB has made this decision of its own accord.
- The concept of academies belonging to small, local MATs is to support school improvement between good/outstanding schools and those schools which are not yet in that position. Those schools which have put forward proposals to create MATs with just other good/outstanding schools have been rejected by the DfE as it is not the intention that all such schools join together without including an equivalent number of schools which need support.
- Staff and students have all worked incredibly hard to ensure that the only issue from our last
 OFSTED (value-added in the 6th Form) has been addressed, and this has improved over the past two
 years. We were the only grammar school in the entire area last year to achieve positive valueadded scores for our 6th form, and the average grade at A level (B-) was higher than any other state
 school in the area.

I would also like to clarify some further misunderstandings which some parents have been asking about. In the event of the governors deciding to become an academy, the ownership of the land which the buildings presently occupy will not change,. It will remain in the hands of the Simon Langton Endowment Trust, with whom we will come to a supplemental legal agreement, so that the school continues to occupy the buildings, exactly as it does now. The playing fields will remain as local authority land, and be leased back to the school on a 125 year lease. By asking several other grammar schools in the area and others such as St Anselm's, we are told that most schools do not even notice changing status – the parents, staff and students all operate in exactly the same way as before. The major change for any one group is in the governance, which is strengthened. A parent was quoted in the paper last week as saying that there will be 'zero accountability' and precisely the opposite is the case, there will increased levels of accountability to ensure that standards across the trust continue to improve. A new academy trust, should this be a result of consultation, would be directly accountable to the DfE through the Regional Schools Commissioner.

We are all passionate about preserving this wonderful school's history, it is part of who we are and the Governing Body would not be consulting on becoming an academy if the result of this was that the ethos would change. The name of the school will remain as it is; we will continue to be a girls' grammar school for Yrs 7-11, with boys in the sixth form; we will continue to ensure that the students here at SLGGS get the best state school education that money doesn't have to buy.
