Annwyl Gyfaill

Rwy'n ysgrifennu atoch i'ch atgoffa bod rhaid i Awdurdodau Lleol gyflwyno gwybodaeth i Lywodraeth Cymru erbyn **31 Mai 2017**, gan ddefnyddio'r ffurflen a ddarperir, am y modd y maent yn cynllunio i wario'r Grant ar gyfer Ysgolion Bach ac Ysgolion Gwledig, gan nodi:

- sail y dosbarthiad a chyfanswm y cyllid a ddyrannwyd i ysgolion;
- disgrifiad byr o broiectau penodol a gefnogir a'r costau a amcangyfrifir; ac
- o dan ba un o'r pedwar diben y mae'r cyllid yn disgyn ar gyfer pob proiect. (Gellir nodi mwy nag un o'r dibenion, e.e. gall rhannu swyddogaethau ystafell gefn gyfrannu at ddiben 3 ond gallai hefyd gyfrannu at ddiben 1 a 2).

Ar yr amod y byddwn yn cytuno â'ch cynllun, rydym yn bwriadu anfon eich llythyr dyfarnu ffurfiol atoch erbyn **30 Mehefin 2017**, yn cadarnhau swm y grant ac yn atodi telerau ac amodau'r grant. Bydd gofyn ichi lofnodi a dychwelyd y rhain ataf cyn gynted â phosibl ar ôl hynny.

Gwneir pob taliad grant i awdurdodau lleol wedi iddynt gyflwyno dogfen hawlio yn rhoi manylion y costau a ysgwyddwyd hyd at ddyddiad y cais hwnnw. Gellir cyflwyno hawliad cychwynnol gydag adroddiad cynnydd cysylltiedig erbyn diwedd **Medi 2017** (telir mewn ôl-daliadau), a bydd angen adroddiad diwedd blwyddyn sy'n cynnwys y gweithgarwch a'r hawliad am gostau a ysgwyddwyd (telir mewn ôl-daliadau) erbyn **28 Chwefror 2018**. Dylid cyflwyno'r adroddiad perfformiad terfynol i Lywodraeth Cymru erbyn diwedd mis **Mai 2018**.

Dear Colleague

I am writing to remind you that Local authorities must submit to the Welsh Government by **31 May 2017**, using the pro-forma provided, details of their planned expenditure of the Small and Rural Schools Grant, indicating:

- the basis of distribution and total funding allocated to schools;
- a brief description of specific projects supported and estimated costs; and
- Under which of the four purposes the funding falls for each project, (This may be more than one of the purposes e.g. sharing backroom functions may contribute to purpose 3 but may also contribute to purpose 1 and 2).

Subject to our agreement of your plan, we aim to contact you by **30 June 2017**, with your formal award letter confirming the sum of grant and attaching the terms and conditions of grant. You will be required to sign and return these to me as soon as possible thereafter.

All payment of grant will be made to local authorities upon provision of a claim document providing details of the costs incurred up to the date of that claim. An initial claim with accompanying progress report may be submitted by end of **September 2017** (paid in arrears), with an end of year report covering activity and a claim for costs incurred (paid in arrears), will be required by **31 February 2018**. The final performance report should be submitted to Welsh Government by end of **May 2018**.
