Thank you for your request for information which has been dealt with under the terms of the Freedom of Information (Scotland) Act 2002. As your request is in several parts it is re-stated below, in italics, with the relevant response then following immediately after. You asked:

"1. How many one bedroom general needs properties do you have available to Let (voids) this week?"

Answer 1) The number of available properties changes weekly and up-to-date details can be found at http://keytochoice.scotsman.com

"2. How many tenants are deemed to be under-occupying, and needing one bed accommodation?"

Answer 2) At the end of May 2013 there were 3,146 tenants having a 14% reduction in Housing Benefit through the Social Sector Size Criteria or Under Occupation regulations.

"3. How many people are already on the waiting list for one bedroom properties?"

Answer 3) We do not operate a waiting list and do not know how many applicants are specifically seeking a one bedroom property. At the end of 2012/13 there were 25,765 households who had applied for housing.
