### **REQUEST**

\*\*\* In October 2016, Sheffield City Council (SCC) and their contractor Amey, approached South Yorkshire Police (SYP) with a view to SYP supplying appropriate support to their planned tree felling activity. \*\*\*

When in October 2016? Start of the month end of the month? If possible date formal request for prescence was requested.

\*\*\* Police officers were utilised during the SCC led tree felling operation, based on the threat and risk assessment undertaken, the potential protest activity and the fact there were to be eight work sites spread over an area that extended over 900 metres.\*\*\*

Was the risk assessment undetaken by SYP or SCC? When was SYP in it's possission, Would it be possible to recieve a copy? Redacted if nescessary.

#### **RESPONSE**

South Yorkshire Police (SYP) has received a significant number of requests for information under the Freedom of Information Act 2000 relating to SYP's activity and involvement in connection with the recent felling of trees in and around Sheffield.

The Freedom of Information Act provides the public with access to all <u>recorded</u> information held by public authorities (unless the information is exempt). In an attempt to be as open and transparent as possible, and negate the need for individuals to make requests for specific information, we have taken the decision to provide the public with access to <u>all</u> disclosable material by publishing the enclosed documentation in relation to the 'tree felling in Sheffield' within the provision of the FOI Act.

Some information has been withheld under the following exemptions, Section 40 Personal Information and Section 31 Law Enforcement which is also explained and considered within a Harm and Public Interest Test within the notification documentation.

### <u>Appeal Process for Freedom of Information</u>

Using this process will not affect your right to appeal directly to the Information Commissioner. However, it will usually be quicker if matters can be resolved locally using this process.

#### Who can appeal?

Anyone who has requested information from the Force in writing can appeal within 20 working days from the date of the response provided. If you have requested information and you are not satisfied with the way we have dealt with your request, you can use the appeal process to have it looked at again. If someone who requested information would like to appeal but cannot do so themselves you can appeal on their behalf, but it will help us if you

make it clear that you are doing so.

### What can I appeal about?

You can appeal about the range, amount and format of information we have sent following a request. You can also appeal about the way a request was handled – for example, the time it took to respond, or the way letters were worded.

### How do I appeal?

You can appeal by writing, emailing or faxing your appeal/complaint to the address below. To deal with your appeal as quickly as possible, it will help if you can give us as much information as you can about the request made, such as the reference number, and the reason for your appeal/ complaint.

## What happens to my appeal?

Once we have enough details to identify the request you are concerned about, a qualified person, other than the initial decision maker, will deal with the internal review.

### How long does it take?

Whatever their conclusion, you will be informed of the result as soon as possible, and in any case within 20 days of submitting your appeal.

If you are still not satisfied, you may then appeal to the Information Commissioner.
