Freedom of Information Act 2000

Please see our response to your Freedom of Information request below and attached.

The final financial viability summary for BH2017/02680 in Section 9.1 says you were given evidence of comparable sites by the valuer.

Please state

- (a) how many comparable sites were identified
- (b) how many of those (a) sites were in or adjacent to an AQMA
- (c) how many of those (b) sites had their D2 use approved before the AQMA was declared.

The Valuer may have provided additional notes about how the restrictions for sites (c) were factored into the valuation (e.g. the need for a full EIA), please state

- (d) whether such notes were made
- (e) if such notes were made, what was their content (a redacted copy of the notes covering just that issue will suffice).

I refer to your request for documentation in relation to planning application ref. BH2017/02680, specifically, the comparable evidence referred to in Section 9.1 of the Final Financial Viability Summary (attached).

Unfortunately I have to advise that para. 9.1 of the document contains a typographical error in that reference to "D2 use establishments" should have been a reference to "D1 use establishments". D1 use establishments would include non-residential educational uses. This error has been confirmed by the applicant.

In answer to your request and referring to your lettered questions:

- (a) the list of comparable sites is attached together with further information supplied in relation to two of the sites;
- (b) the Council does not hold any documentation in relation to this question;
- (c) the sites are evidence of D1 use as above; the Council holds no information regarding use save as attached;
- (d) and (e) if any such notes were made these are not held by the Council.
