## FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

Further to your email dated 26<sup>th</sup> September 2012, requesting information under the Freedom of Information (Scotland) Act 2002. I can advise you as follows.

Fife Constabulary does not record the physical status of either the victim or perpetrator of crimes except where the individuals concerned has provide their occupation as "disabled". To assist you the table below provides details of when a perpetrator or Complained has provided their occupation as 'disabled'.

of Rape or Indecent Assault charges recorded in the fiscal years as reported is then used to calculate the proportion of these charges that are connected to disabled people.

From the above table, there are two rape or indecent assault charges where the complainer has an occupation of disabled.

Fife Constabulary does not record crimes by type of impairment.

All Fife Constabulary officers' receive disability awareness training; Probationers receive it at Scottish Police College where it is incorporated into Equality and Diversity (E&D) training. All other Police staff receive the same training, which is over 2 days E&D training within the force. Fife Constabulary is also in the process of organising disability "road-shows" where training and awareness material about disability issues is taken direct to officers in stations.

Fife Constabulary does not provide easy read material at stations. If someone required an easy read response or something specific, we would be able to provide that, via an external service.

If you are not satisfied with the way in which I have dealt with your request, you are entitled, in the first instance, to request a review of the decision made by the Force. If, after having been informed of the review panel's decision, you are still not satisfied, you are then entitled to apply to the Scottish Information Commissioner for a decision within six months of the date of receipt of the review response.
