Where the total number of individuals is 5 or under, the university has replaced the figure with 'equal to or less than five' (\leq 5). The university considers that it is reasonably likely that students could be identified from the low numbers. Such identification would constitute a breach of one of the principles set out in the Data Protection Act 1998 (DPA). This approach is in accordance with the Information Commissioner's Office Code of Practice on Anonymisation. This information is therefore exempt from disclosure under section 40(2) of the Act. This is an absolute exemption which means that the university does not need to consider the public interest in disclosing the information, we only need to establish that the exemption has been engaged.

The methodology the university has adopted is a variation of the HESA standard rounding and suppression method. Numbers that are five or fewer are replaced with "≤5 (less than or equal to five)"; when needed to prevent potential identification all other numbers are rounded to the nearest multiple of five (halves are rounded upwards).
