Thank you for your Freedom of Information request received on 3 March 2019. You asked:

"Please can you supply the claimant count of Black British ESA/JSA claimants in the period of June 2017 until April 2018 as a percentage of the total population of claimants of ESA/JSA.

Can you also supply the claimant count of Black British ESA/JSA and universal credit claimants in the period of May 2018 until March 2019 as a percentage of total population of ESA/JSA and universal credit claimants.

Please will you supply the figures of the number of Black British people in receipt of JSA/ESA and universal credit who have been sanctioned ,both under the legacy benefit system and the Universal credit system, in all branches of Job centre plus in the Leicester city area since June 2017 until April 2018 and for the period May 2018 until March 2019.

Please supply these figures as a percentage of the total population of ESA/JSA and Universal credit claimants, sanctioned both under the legacy benefit system and the universal credit system."

We can confirm that whilst we may hold some information falling within the description specified in your request we estimate that the cost of complying with your request would exceed the appropriate limit for central Government set by regulations at £600. This represents the estimated cost of one person spending $3\frac{1}{2}$ working days in determining whether the Department holds the information, and locating, retrieving and extracting it. Under section 12 of the Freedom of Information Act (FOIA) the Department is not therefore obliged to comply with your request and we will not be processing it further.

Under section 16 of the Act we should assist the requester in helping narrow their request so that it may fall beneath the cost limit. Once you have reviewed the information below you may wish to narrow your request accordingly by removing the nationality aspect and also aligning it to the dates of the published statistics. If you wish to submit a revised request, we will consider it however we cannot guarantee that any revised request will fall within the cost limit.

The Department publishes Official Statistics on various benefits, and the latest information available for Universal Credit (UC) to January 2019 and Employment and Support Allowance (ESA) to August 2018 can be extracted from Stat-Xplore here: https://stat-xplore.dwp.gov.uk/

You may also be interested to know that the ESA statistics are available by ethnicity. The Office for National Statistics' (ONS) population estimates are also available on Stat-Xplore.
