I would like to request for the statistics of 2020 entry BDS course:

1. Total number of international applicants

There were ninety (90) international applicants.

2. Number of international applicants offered an interview

Thirty-two (32) were offered an interview.

3. Number of international applicants offered a place

Twenty-one (21) were offered a place.

4. Minimum and Maximum UCAT score of international applicants who were offered a place

Minimum UCAT score was 2630, the maximum UCAT score was 2850.

The Coronavirus (Scotland) Act 2020 provides for an extension to the normal timescale for response to FOI requests for review to 60 working days from receipt of a request. You will receive a full response to your request for review within 60 working days of its receipt.

If you are dissatisfied with the way in which we have handled your request for review you may ask the Scottish Information Commissioner to review our decision.
