Your freedom of information requests

Thank you for your two emails of 15 January 2019 requesting information about off-payroll legislation implementation and compliance.

I apologise for the delay in providing this response; unfortunately we are currently experiencing an exceptionally high volume of requests and resource shortage.

Number of off-payroll worker (IR35) assessments since April 2017

You requested number of assessments since April 2017 made to determine if an 'off-payroll' worker was considered an employee, with the number of assessments that are considered to be "inside IR35" (i.e. 61M(1)(d) applies) and the number that are "outside IR35" (i.e. 61M(1)(d) does not apply). Table 1 provides the number of assessments of 'off-payroll' workers performed from 1 April 2017 to 15 January 2019, and whether they were determined to be inside, or outside, of IR35. An 'off-payroll' worker may assessed more than once. Therefore, Table 1 shows the number of assessments, and may not match the number of individual 'off-payroll' workers.
