Dear Mr Dube,

We refer to your request of 16 July, where you asked:

[1] • May I have a breakdown of the names of magazines, newspapers, journals, periodicals, and publications that the Department has subscriptions to?

[2] • For the publications that the Department has delivered, may I have a breakdown of how many copies of each issue the Department receives as part of its subscription?

[3] • May I also have a breakdown how much it costs the Department to subscribe to each publication?

We have dealt with your request under the Freedom of Information Act 2000 ('the Act').

The Department for Exiting the European Union (DExEU) holds information within the scope of your request.

For the purposes of this response, we have numbered your requests 1, 2 and 3.

Request 3

We have interpreted your request 3 as a request for the cost of subscribing to each publication in the 2019-2020 financial year up to the date of your request.

Information on the individual cost of hard copy subscriptions is not held. DExEU purchases the hard copy editions of the above newspapers from a single provider and is invoiced for these costs on a monthly basis. From the beginning of the 2019-2020 financial year up to the date of your request, DExEU spent £3,628.29 on hard copy subscriptions.

The costs of online subscriptions paid by DExEU are as follows:
