Dear Mrs Greasley

I write in reply to your email requesting the above information.

Please refer to the attached data. Owing to the risk of individuals being identified in a manner that would breach data protection principles, we are unable to provide the full information requested or provide information in the exact form requested. In providing the alternative data attached, we have applied the exemption from disclosure in section 40(2) of the Freedom of Information Act (FOIA). Section 40(2) provides an exemption from disclosure for information that is the personal data of an individual other than the requester, where disclosure would breach any of the data protection principles in Article 5 of the General Data Protection Regulation (GDPR). We consider that disclosure of the information requested in the exact form requested would breach the first data protection principle, which requires that personal data is processed lawfully, fairly and in a transparent manner. Disclosure would be unfair to the individuals concerned, as it would be contrary to their reasonable and legitimate expectations. They would not reasonably expect that information about their application to Oxford would be made public under the FOIA without their consent.

For the disclosure of personal data to be lawful, it must have a lawful basis under Article 6 of the GDPR. There are six possible lawful bases in Article 6; we do not consider that any of them would be satisfied in respect of the disclosure.

THE INFORMATION COMMISSIONER
