Dear Mr Benjamin

Thank you for your email of 30 September in which you request access to the following under the Freedom of Information Act 2000 ('Fol Act'):

'....annual statistical data & relevant reports on the total deposits (investments) placed by UK local authorities for each financial year between 2001/02 and 2009/10 with UK and foreign banks, building societies and money market funds.'

The Bank of England (the 'Bank') publishes data from September 1997 to August 2018 which provides sterling and foreign deposits by local authorities.

This can be viewed within table 'B2.1.1 - Monetary financial institutions' consolidated balance sheet – further sectoral breakdown' which is available on our website at https://www.bankofengland.co.uk/statistics/tables.

To access the data, click on the plus sign on the right hand side of the heading 'B2.1.1- Monetary financial institutions' consolidated balance sheet – further sectoral breakdown' and the data series we publish will display. The information is available in the second block of data in the tables. For further data select the four digit code within the Local Government columns of the table, you will then be asked to enter the timeframe in which you are interested. You should then click on the red 'View Data' button and the information will be displayed.

The Bank does not hold data on local authority holdings of money market funds. You may be interested to know that the information may be available from the Institutional Money Market Funds Association whose contact details can be found on their website at https://www.immfa.org/.
