Please see below the response to your enquiry under the Freedom of Information Act received on 27th February 2020.


The details we require are:

All submissions received were evaluated as part of the tender process due to all suppliers passing the Mandatory Questionnaire and from that, City of York had the top 3 suppliers on a ranked framework.

- 1. NPS Property Consultants Ltd
- 2. NORR Consultants Ltd
- 3. WM Saunders Partnership Ltd

As this is a Framework with a contract life of four (4) years, there are no extension options available for City of York to take. The end date for this is 17th May 2021.

A review date of 1st January 2021 has been set which means this is when City of York will review the contract and the requirements and re-procure if required. No decision has yet been made.
