Adult Care Services (age 18+) and Children and Young People's Services (16-17) are not part of a Regional Framework for Supported Accommodation. Services are procured via a competitive tender process using the YorTender portal.

Adult Care Services Commissioning Team undertakes a process of specifying, securing and monitoring services to meet people's needs at a strategic level. We look at the total picture of needs across the borough, capturing the budget and funding available to meet these needs and developing the best strategic fit for service delivery.

The Commissioners encourage providers to work with us to co-produce services. This approach means that the Adult Care services are transparent and inclusive and creates an environment where people can be creative and try new things.

A tender process for a local framework for accommodation and support for 16 and 17 year olds will be undertaken in March 2019.
