Dear Mr Boston-Dunn,

Thank you for your email of 29th July 2018 requesting the following information:

I have bought a land rover snatch 2a and I'm currently going to all efforts to restore it. I am finding very little information and seem to be missing some parts. I would like to request for such diagrams as Wiring diagrams A/c set up Engine diagrams etc.

This will help me restore it back to its former glory.

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000.

On 28<sup>th</sup> August 2018, we informed you that some of the information related to your request fell within the scope of qualified exemptions: Section 26 (Defence) and Section 38 (Health & Safety). As such we needed to conduct a Public Interest Test, to determine whether in the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosure.

Upon closer examination of your request we have concluded that in order to provide a full response the Ministry of Defence (MOD) requires further information in order to determine whether it holds the correct information within the scope of your request. With particular reference to "Engine Diagrams", it would be useful to know what kind of engine diagram you are interested in, e.g. maintenance instructions. Once you have clarified this part of your request I will be pleased to consider it again.

If you have any queries regarding the content of this letter, please contact this office in the first instance.

If you wish to complain about the handling of your request, or the content of this response, you can request an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail <a href="CIO-FOI-IR@mod.gov.uk">CIO-FOI-IR@mod.gov.uk</a>). Please note that any request for an internal review should be made within 40 working days of the date of this response.

If you remain dissatisfied following an internal review, you may raise your complaint directly to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
