#### NICE guidance on Type 2 Diabetes in Adults

#### New decision support tool for anticoagulant choices in atrial fibrillation (AF)

NICE has endorsed a new decision support tool that aims to help healthcare professionals and people with AF make informed decisions about the most appropriate treatments. The online tool is in two parts and encourages partnership between patients and healthcare professionals when reaching a decision about the use of anticoagulants to reduce the risk of stroke.

#### Antiplatelets in combination with NOACs

UKMI has produced a useful Q&A document which looks at co-prescribing of antiplatelet agents and NOACs.

What are the risks of using antiplatelet agents in combination with the Novel Oral Anticoagulants (NOACs) in patients with atrial fibrillation, and how should the potential risks be managed?

#### • Over-ordering by Dispensing Appliance Contractors (DACs),

Following some audits of the prescribing of continence products there is a concern that a significant number of requests from DACs, on behalf of patients, are for items that are not needed. In response the CCG has drafted a letter which GP practices can send to DACs detailing which items are required and for which a prescription has been provided. It is hoped that this will prevent the DAC recurrently requesting the items that have not been prescribed by the GP and will help prevent requests for retrospective prescribing. #### First E-cigarette licensed by the MHRA

The MHRA has licensed an e-cigarette called e-Voke. However, GPs and nurse prescribers are asked <u>not</u> to prescribe this currently as the Local Authority are the responsible commissioners for smoking cessation; therefore the CCGs await their decision regarding funding of e-cigarettes at NHS expense in Northamptonshire.

#### Non-medical prescribers (NMPs)

The Medicines Management Team is regularly contacted by the NHS Prescription Service regarding a number of NMPs who are using FP10 forms but they are not registered on the NHS Prescription Services database. All practices are reminded that they should complete the relevant form for each NMP working in the practice.
