Attention is drawn to the recent letter from Flynn Pharma Ltd to Doctors and Pharmacists regarding the discontinuation of Epanutin Capsules. All other presentations of Epanutin continue to be available. Flynn Pharma Ltd recently acquired the Marketing Authorisations for Epanutin capsules, following which the name has been changed to Phenytoin Sodium Flynn Hard Capsules. Epanutin will no longer be available as soon as current Pfizer. stocks are exhausted and at that point future prescriptions must be written as "Phenytoin Sodium Flynn xmg Hard Capsules". Pharmacists and GP practices will need to liaise accordingly to ensure that the correct product is prescribed.

#### Nasal influenza vaccine (Fluenz)

The Green Book advises that the nasal vaccine (Fluenz) is the preferred vaccine for children aged two to less than 18 years. Currently patients in this age group should only receive a flu vaccine on the NHS if they are in one of the listed clinical risk groups.

However Fluenz should **not** be given to patients with certain immunodeficiencies (see contraindications), with severe asthma (British Thoracic Society and Scottish Intercollegiate Guidelines Network (BTS SIGN) step 4 or above), active wheezing at the time of vaccination or when pregnant (see precautions).

It is anticipated that the number of patients aged two to less than 18 years in one of the clinical risk groups is small (especially once patients with immunodeficiencies and asthma/wheezing are excluded) and therefore Fluenz has not been included in this season's PGD. Any supply would need to be prescribed for the individual patient or via a patient specific direction.

# Bisphosphonates for osteoporosis: how long should treatment be continued?

This is a subject that we are often asked about but the evidence is not clear or conclusive. A recent Medicines Evidence Commentary from NICE considers <u>a systematic review</u> by the US Food and Drug Administration of the long-term safety and efficacy of bisphosphonates and has suggested that, in postmenopausal women with osteoporosis who have been treated for 3–5 years, there was no additional benefit on fracture rates from further treatment, but also no additional harm. However, data are limited and general conclusions are difficult to draw.
