REQUEST FOR INFORMATION: TB IN DOMESTIC ANIMALS

Thank you for your request for information, which we received on 24 January 2018, about Bovine Tuberculosis in domestic animals. We have handled your request under the Freedom of Information Act 2000 (FOIA).

In your request for information you asked:

"Please can I have figures on the number of domestic animals that tested positive for TB in the UK over 2016 and 2017 as well as the number that were tested for the disease?

Animals tested to include domestic dogs, cats and horses."

The following link provides the information for 2016 https://www.gov.uk/government/statistical-data-sets/other-tb-statistics. Domestic animals (including cats and dogs) are included in the "other" column. This would include any species other than goats, sheep, pigs, camelids and deer.

With regard to horses, those may also be included in the "other" column but horses are not routinely tested for TB as they are fairly resistant to the infection. The number of confirmed cases of equine TB documented in the veterinary medical literature worldwide is extremely low.

The annual statistics for 2017 are not yet available but will be published on the above link in due course.

As the information you requested is publicly accessible, your request is exempt from disclosure under the Freedom of Information under section 21 FOIA.
