Your email dated 23 January 2018 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

I am requesting technicle information and documents / data for my exMoD Land Rover Defender 90. Military registration was 18KK29.

I am asking especially for a

- *maintenance history list*
- *repair action list*

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. Unfortunately, following the closure of MERLIN it is only possible to retrieve information held on the archived version of the database, which is attached.

Some information falls within scope of section 40(1) of the FOIA. This states that information is exempt if it constitutes personal data. Where this is the case, the information has been redacted.
