PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about recruitment, which the Animal and Plant Health Agency (APHA) received on 25 January 2023. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"Dear Animal and Plant Health Agency,

Please could you provide the following information under the freedom of information act covering the last 12 months, or the most recent 12 month period recorded:

- 1. Has the organisation used agencies to recruit temporary/contractor staff?
- 1a. If so please confirm the total agency spend on temporary/contractor staff??
- 1b. Please provide a breakdown of your answer to question 1a, splitting the spend by job title/specialism
- 2. Has the organisation used agencies to recruit permanent staff?
- 2a. If so please confirm the total agency spend on permanent staff?
- 2b. Please provide a breakdown of your answer to question 2a, splitting the spend by job title/specialism
- 3. The contact name of the person responsible for dealing with permanent recruitment?
- 4. The contact name of the person responsible for dealing with temporary/contractor recruitment?"

The information you have requested has been exempted from release citing section 12 of the Freedom of information Act (FOIA)

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

Section 12

Recruitment of both agency and permanent staff are often carried out at a local level with the choice of advertising or of agency up to individual departments and offices. This also include which individual budget this is paid from.

For APHA to approach each individual department to find out what method of recruitment they use would be a huge task.

The exemption Section 12 (2) is an exemption to release on the grounds of cost.

The Act recognises that Freedom of Information (FOI) requests are not the only demand on the resources of a public authority. They should not be allowed to cause a drain on their time, energy and finances to the extent that they negatively affect their normal public functions.

Currently, the cost limit for complying with a request or a linked series of requests from the same person or group is set at £600 for central government, Parliament and the armed forces and £450 for all other public authorities. You can refuse a request if you estimate that the cost of compliance would exceed this limit. This provision is found at section 12 of the Act.

You can refuse a request if deciding whether you hold the information would mean you exceed the cost limit, for example, because it would require an extensive search in a number of locations. In all likelihood we do hold this information, but cannot provide the information itself under the cost ceiling.

APHA have decided that the request falls under this exemption and are refusing to search for the information requested.
