Re: FOI Linked to Case refs: 902 & 750 - Origin of ingredients developed for Anthrax for 1990/91 Gulf War

Thank you for your email dated 18 December 2019. In accordance with Section 1(1)(a) of the Freedom of Information Act 2000 (the Act), I can confirm that Public Health England (PHE) does not hold the information you have specified.

Your request:

Please release the correct data surrounding the vaccine ingredient supplies

Response:

Your request is very similar to your original request of the 22 November 2019 (Case ref: 750). You will recall you requested the following:-

What has already been clarified is that the U.S formula was used to develop Anthrax vaccines for use on British troops specifically for the Gulf War 1999/1991 .My simple question is as follows...Did the U.S also supply the anthrax bacteria or any other ingredient within that vaccine?

We responded to your request by advising PHE did not hold the information specified. We also provided a useful point of clarification.

By return, we received a subsequent clarification from you as follows:-

This leaves MOD with a bit of problem, as without knowing the origin of the ingredients/bacteria specifically for the Anthrax developed for the Gulf War 90/91 as MOD are claiming, it is simply impossible for them to make the claim that the Anthrax did not cause gulf war illnesses/autoimmune conditions amongst our suffering troops!

Would you just like to double check, especially as MOD would like us to believe every stone was turned!

PHE responded within the required timeframe and provided advice and assistance to you under our Section 16 duty, signposting you to the Government of UK Ministry of Defences' position on risk from vaccines and Nerve Agent Pre-treatment Set is documented at; https://www.gov.uk/guidance/gulf-veterans-illnesses#the-vaccines-interactions-research-programme

Your most recent request of the 18 December 2019 is as follows:-

Please release the correct data surrounding the vaccine ingredient supplies
