We can confirm that the information requested is held by Brighton & Hove City Council. We have detailed below the information that is being released to you.

1. At what Full Council Meeting was the Public Funding of the i360 approved?

The funding of the i360 was approved by a Special Meeting of the Policy & Resources Committee on 6 March 2014. Reports are available on the council's web site.

2. Which Councillors voted for the Public Funding of the i360; which abstained; and which voted against?

Green councillors J Kitkat, J Bowden, I Davey and B Randall voted in favour. Conservative councillors G Theobald, G Peltzer-Dunn and A Norman voted in favour. Labour & Co-op councillors W Morgan, L Hamilton and J Lepper voted against.

3. What was the amount owing to Brighton and Hove City Council by i360Ltd at June 2019?

The amount of the loan to the i360 Ltd by Brighton and Hove City Council at 30/06/2019 was £37.366 million

4. What was the amount owing to Brighton and Hove City Council by i360Ltd at Dec 2019?

The amount of the loan to the i360 Ltd by Brighton and Hove City Council at 31/12/2019 was £38.196 million after allowing for a £0.312 million adjustment

where the council received funds that were due to the Coast2Capital Local Enterprise Partnership. Details of this adjustment are included in papers to the council's Policy & Resources Committee on the 5th December 2019 which are available on the council's website.
