**Information request**

Thank you for your email of 6th November 2018. You requested the following information:

'I am writing to request information under the Freedom of Information Act 2000. In order to assist you with this request, I am outlining my query as specifically as possible.

What was the number of train cancellations in Lincoln and in Cambridge separately, in the time period of 1st January 2018 to 1st September 2018? I ask this as both cities have similar populations and it would, therefore, be a fair comparison. This includes data on uncompleted journeys to the cities if possible.

I would be interested in any information held by your organisation regarding my request. I understand that I do not have to specify particular files or documents and that it is the department's responsibility to provide the information I require. If you need further clarification, please contact me by my email address.

I would like to receive the information in electronic format'

I have processed your request under the terms of the Freedom of Information Act 2000 (FOIA).

I can confirm that we hold the information you requested. To assist you in drawing a fair comparison between these two stations it may be worth noting that although Cambridge and Lincoln have a similar population size, the number of trains which service these stations is very different. Therefore, I have included the total number of trains planned to stop at the station as well as the number of cancelled services. Please see below a table which shows the total number of trains and the total number of cancellations between the 1<sup>st</sup> January 2018 to 1 September 2018:

Cambridge	86,855	5,493	
Lincoln	27,544	350	

We have defined cancellations as any timetabled train that was due to call at one of the above stations and does not have a recorded time in TRUST<sup>1</sup>. Therefore, this figure includes services that were cancelled before reaching the stations and any train that failed to stop at the station<sup>2</sup>. Cancellations can occur for a variety of reasons ranging from signalling problems to driver shortages. These cancellations may be responsibility of Network Rail, a Train Operating Company or a Freight Operating Company.

To assist you further in drawing a comparison I have also included an extract from the Office for Rail and Road's Estimated Station Usage Report for 2016-2017<sup>3</sup>. This extract shows that Cambridge has a significantly higher number of passengers compared to Lincoln.
