Freedom of Information Request

Thank you for your e-mail of 5 February requesting information under the terms of the Freedom of Information Act 2000 (FOIA).

You asked:

Please can you tell me the number of supercars as listed below that are registered to women and men in the UK:

Lamborghini - all models

Aston Martin - all models

Ferrari - all models

McLaren - all models

Bugatti - all models

Bentley - all models

Porsche - all models

Maserati - all models

I would like the separate figures for women and men.

The information we hold is shown below and is correct as of 31 December 2019.

We do not hold information on the age or gender of the vehicle keeper. However, the figures below indicate where a title has been provided by the registered keeper. 'Other' refers to those keepers that have specified a different title such as Dr, Rev or Ms. It is not possible within the cost limits applying, to provide a breakdown of the information by these 'other' titles. Under Section 12 of the FOI Act, the DVLA is not obliged to comply with a request where the estimated cost of determining, locating, retrieving and/or extracting the information exceeds £600.
