Dear [REDACTED],

We were not informed prior to the felling activity with the last tree. In fact, we had been engaging the landowners around the need to give us plenty of prior warning so that we could plan our operational response. We were disappointed to find out that the work had taken place, having had reassurances only a few days earlier that nothing was planned for the foreseeable.

Following the activity on site, three allegations were made to us, against the landowners and their staff. One is from a lady [REDACTED], but has provided no evidence to substantiate that. The other two involve allegations of minor assault where protesters are alleging that they were manhandled away from the site. Again, evidence from those initially bringing the claims has not been substantiated.

I am moving away from the St Pauls team as of next week, but this matter will be closely monitored by my replacement [REDACTED], and [REDACTED] (both copied in). Our plan is to engage concerned residents and members of the campaign group, [REDACTED], in a virtual meeting in the next couple of weeks, and it would be beneficial to have you both there as well I'm sure. If that is acceptable, I believe [REDACTED] will be setting up a date soon.

Dear Thomas,

I hope you are well.

I have been contacted by [REDACTED] regarding the M32 Maple which as you will be aware was recently felled.

[REDACTED] has a few outstanding queries. I have shared the fact that local councillors were not aware that the Maple was going to be felled on that morning but have been aware of the "intention" of the land owner to do so for an extended period, as indeed all parties have been aware from the outset including [REDACTED] herself.

This has been a long and difficult journey.

[REDACTED] has informed me that charges have been pressed regarding common assault and also the incident of felling included an activist being present in the tree at the time of felling. I do hope that there will be appropriate resolution of these matters. Please keep us updated.

I do believe that there are lessons to learn that may be helpful for other similar situations in the future which this experience could inform.

Would you be so kind as to update us regarding all these matters. Working in partnership would be beneficial moving forward and I would welcome your thoughts on this.
