- What theatre management system do you currently use?
- When did the contract start for the theatre management system that you use?
- When does the contract end for the theatre management system that you use?
- Who is the main person responsible for the management of the theatre management system?
- What are the contact details for the person responsible for the management of the system?
- How much do you spend on the support for the system on an annual basis?
- How many years is the theatre management system contract in place for?

Having completed enquiries within the Trust and in respect of Section 1(1)(a), C&I NHS FT does not hold information relating to your request.

Due to the nature of the services C&I NHS FT provide and as an Adult Mental Health Trust, this FOI request is not applicable to the Trust as we do not perform operations on our patients.

Camden and Islington NHS Foundation Trust is a Mental Health Trust, providing high quality, safe and innovative care to our patients in the community, in their homes or in hospital.

We provide services for adults of working age, adults with learning difficulties, and older people in the London area. We currently deliver the majority of our care to residents in the London Boroughs of Camden and Islington. However, we also provide substance misuse services in Westminster, and substance misuse and psychological therapies service to people living in Kingston.

In addition, we have specialist programmes which provide help and treatment for:

- **Veterans living in London;**
- **Young people caught in the cycle of gang culture, and**
- **Older people living with dementia and other age-related mental health conditions.**
