Under the freedom of information please could you confirm the following; (I have the answers on good authority)

- 1. 1.3 million tests over 2 years by ATOS?
- 2. 11,000 sick claims seen a week?
- 3. ATOS is a french company?
- 4. ATOS paid 100 million pounds per year for contract?
- 5. 39% of the above 1.3 million deemed fit for work?
- 6. 17% able to do some sort of work?
- 7. 7% genuine incapable of any kind of work?
- 8. 36% dropped out of the system so in essence the scroungers?
- 9. To sum up in rounding up 25% had good cause to claim.
- 10. 75% did not according to ATOS.
- 11. And of those 75% half of them are APPEALING and the estimate for the appeals tribunal to clear them 5 years. lol

The letter of the Freedom of Information Officer dated 24 August 2011 (FOI 2189) refers.

In answer to **Q8**, there are a number of reasons why Employment and Support Allowance (ESA) claimants might legitimately come off ESA before they undergo the WCA if their illness or incapacity is not a long term condition. The whole purpose of ESA is to provide help and support to people who cannot work because of illness or disability and this approach is equally valid for those with both long and short-term medical conditions. For the published statistics relating to your query please use the link above.

In reply to **Q10**, decisions on entitlement to ESA rest solely with the Department's decision makers taking into account the medical assessment reports from Atos and any other relevant information. For the published statistics relating to your query please use the link above.

In response to **Q11**, 37% of those people found fit for work have lodged an appeal (to date) and 61% of these appeals have been found in favour of the Department.
