Freedom of Information Act 2000 - RFI20171435

Thank you for your request of 27th September 2017 for the following information under the Freedom of Information Act ('the Act'):

"Tickets received by the BBC for sporting events for the period October 1st 2016 to September 30th 2017. (e.g. Wimbledon 12, FA Cup final 12) recipients by job title. (e.g. camera person - 12, Director 12)"

We have now processed your request and I can confirm that under section I(I) of the Act, we confirm that we hold some of the information you have requested. As you are aware, it is normal business practice for broadcast rights holders to be provided with complimentary tickets to sports events. I can confirm that BBC Sport receives such tickets as part of some of its rights deals.

BBC Sport utilises some of the tickets it receives from rights holders for production purposes. Where BBC Sport uses tickets for production purposes, the information is excluded from the Act because it is held for the purposes of 'journalism, art or literature'. Part VI of Schedule I of the Act provides that information held by the BBC and the other public service broadcasters is only covered by the Act if it is held for "purposes other than those of journalism, art or literature". The BBC is not required by the Act to supply information held for the purposes of creating the BBC's output or information that supports, and is closely associated with, these creative activities.

BBC Sport holds the following information on the allocation of the complimentary tickets it receives to sporting events. We do not retain records of the job titles of recipients.
