Dear Mr Magnall,

Your request was received on 1 November 2017 and I am dealing with it under the terms of the Freedom of Information Act 2000 ('the Act').

You asked:

*Please could you provide me with the total number of PhD applicants to [Cambridge] University for the period September 2016 – September 2017. Breakdown by internal vs external applicants and the total successful applications, would be appreciated.*

The requested information is attached. We have taken 'internal' to mean an applicant who had previously studied at Cambridge. The date range is 1/9/16 to 30/9/17. Please note that the attached document should not be copied, reproduced or used except in accordance with the law of copyright.
