### 1. BACKGROUND

- 1.2 Section 37 of the Local Government Act 2000 requires a local authority which is operating executive arrangements to prepare and keep up-to-date a Constitution. The City Council adopted a Constitution on 12 September 2001 when it began operating executive arrangements. It was recognised at that time that amendments would need to be made to reflect operational needs, changing circumstances and new statutory requirements and guidance.
- 1.3 The City Solicitor is required to monitor and review the operation of the Constitution on an on-going basis and, where necessary seek the Council's approval to amendments.

#### 2. OPERATIONAL CHANGES

- 2.1 On 10 November 2005, Personnel Committee revised strategic management arrangements for the Council and new arrangements for the management of the Manchester Improvement Programme.
- 2.2 The change included the Strategic Director (Operations) taking overall responsibility for the co-ordination, management and delivery of the Manchester Improvement Programme and the establishment of a new post of Strategic Director of Neighbourhood Services. The Committee also approved the temporary re-assignment of the line management responsibilities of the Strategic Director (Operations) to other senior officers.
- 2.3 As a result of these changes, it has been necessary to review the Scheme of Delegation in order to ensure that the powers which were previously delegated to the post of Strategic Director (Operations) are transferred to the appropriate alternative Chief Officers.
- 2.4 The proposed variations to the Scheme of Delegation are detailed in the Appendix. This identifies the powers which are currently delegated to the post of Strategic Director (Operations), and the Chief Officer to whom it is proposed they should be delegated following the changes.
- 2.5 These interim amendments to the Constitution's scheme of delegation are to take effect immediately. They will be reviewed when the Strategic Director of Neighbourhood Services is appointed.

#### 3. **RECOMMENDATIONS**

3.1 It is recommended that the City Council adopt the temporary variations to the Scheme of Delegation to Chief Officers set out in the Appendix.
