Freedom of Information – Request for Information UNIQUE REFERENCE BT129

I am writing regarding your request for information dated 27 June 2011. You have requested the following information:

- "1. How many hours of paid staff time were spent on trade union duties and activities in 2010-11? Please specify on which unions the time was spent.
- 2. What was the salary grade of the most senior member of staff who spent time on trade union duties or activities in 2010-11?
- 3. How many members of staff in total spent paid time on trade union and activities in 2010-11?

I wish to receive the information electronically."

Your request has been considered under the terms of the Freedom of Information Act 2000 and the information you requested is provided below.

A total of 302.4 hours was spent on trade union duties and activities in 2010-11 – this equates to 8.4 FTE posts.

The salary grade of the most senior member of staff who spent time on trade union duties or activities was Leadership Point 21 on the National Teachers Pay Scale. This grade applies to a part-time post and the pro-rata value is £12,258 (FTE £61,288).

In total, 11 members of staff were employed to carry out trade union duties and activities, 4 within the Council and 7 within schools.

To put these figures into context, the organisation currently employs 1 FTE staff member carrying out trade union duties per approximately 1000 FTE employees.
