DESCRIPTION OF TRANSACTION: - Various Roads, Goole

Temporary Traffic Regulation Order for the closure and speed restriction of the following roads:

Phase 1: The introduction of a 10mph and 30mph speed limit restriction on Boothferry Road between Hook Lane Roundabout and the entrance to West Parkside during the following period:

Monday 10th May 2021 until Friday 21st May 2021 (Working hours 19:00 hours until 06:00 hours - 30mph speed restriction required 24 hours a day for the full duration of works)

Phase 2: To prohibit any vehicle from proceeding along Ferry Lane during the following period:

Monday 10th May 2021 until Friday 21st May 2021

The alternative route for traffic affected by the road closure will be via: Bridge Road, Boothferry Road.

Phase 3: To prohibit any vehicle from proceeding along Landsdown Road during the following period:

Monday 17th May 2021 until Friday 28th May 2021

The alternative route for traffic affected by the road closure will be via: Shaftesbury Avenue, Park Avenue, Airmyn Road.

Phase 4: To prohibit any vehicle from proceeding along Boothferry Road during the following period:

Monday 17th May 2021 until Friday 28th May 2021 (working hours 19:00 hours until midnight - works are expected to take no longer than 5 nights to complete)

The alternative route for traffic affected by the road closure will be via: Rawcliffe Road, Andersen Road, Normandy Way, Bridge Street, Lower Bridge Street, Mariners Street.

Phase 5: To prohibit any vehicle from proceeding along Park Avenue during the following period:

Monday 31st May 2021 until Friday 4th June 2021 (working hours 09:30 hours until 15:30 hours)

The alternative route for traffic affected by the road closure will be via: Shaftesbury Avenue, Landsdown Road, Airmyn Road.

Phase 6: To prohibit any vehicle from proceeding along Centenary Road during the following period:

Monday 31st May 2021 until Friday 4th June 2021 (working hours 09:30 hours until 15:30 hours)

The alternative route for traffic affected by the road closure will be via: Cliftons Gardens, Boothferry Road, Airmyn Road.

Phase 7: To prohibit any vehicle from proceeding along West Parkside during the following period:

Monday 31st May 2021 until Friday 18th June 2021 (working hours 09:30 hours until 15:30 hours - work is expected to take no longer than 5 shifts within this period)

The alternative route for traffic affected by the road closure will be via: N/A

Phase 8: To prohibit any vehicle from proceeding along Airmyn Road Services Road during the following period:

Monday 7th June 2021 until Friday 18th June 2021 (working hours 09:30 hours until 15:30 hours - work is expected to take no longer than 5 shifts within this period)

The alternative route for traffic affected by the road closure will be via: Western Road, Airmyn Road.

Phase 9: To prohibit any vehicle from proceeding along Western Road during the following period:

Monday 7th June 2021 until Friday 18th June 2021 (working hours 09:30 hours until 15:30 hours - work is expected to take no longer than 5 shifts within this period)

The alternative route for traffic affected by the road closure will be via: Oxford Road, Centenary Road, Airmyn Road.

The road closure is necessary to enable the carriageway resurfacing works to be carried out in a manner consistent with ensuring the safety of the public. The Order is valid for 18 months, but it is anticipated that the works will be completed within 6 weeks.

The road will be closed to all traffic, but access will be maintained at all time for residents, emergency services and pedestrians.
