(PARKING PLACES AND CONTROLLED PARKING ZONE) (BIRMINGHAM)
(CONSOLIDATION) (VARIATION) (No.87)
ORDER 2013

Birmingham City Council ("the Council") in exercise of its powers under Sections (1), 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 49, 53, 101 and 102 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order.

1. This Order shall come into operation on the 8th day of March Two thousand and thirteen and may be cited as the "Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) (Variation) (No.87) Order 2013".
2. The "Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) Order 1995" (as amended) shall continue in full force subject to the variations specified in the First Schedule to this Order:

FIRST SCHEDULE (Article 2)

Variations to "Birmingham City Council (Parking Places and Controlled Parking Zone) (Birmingham) (Consolidation) Order 1995" (as amended)

1. In Article 35 within sub article (i) the words ' , VII or VIII' shall be inserted following the words 'Part VI'.
2. In Article 35 sub article (j) shall be deleted and the following sub article shall be inserted:
 - (j) if a vehicle is a disabled persons vehicle which displays in the relevant position a disabled persons badge, and a parking disc (on which the driver or other person in charge of the vehicle, has marked the time at which the period of waiting began), in any of the lengths of road referred to in the said Article for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road) provided that no vehicle shall wait:-
 - (a) during the period between 8.00 am and 7.30 pm on any day in any part of a restricted road specified in Part VI of Schedule 2 to this Order.
 - (b) at any time on any day in any part of a restricted road specified in Part VII of Schedule 2 to this Order.
 - (c) during the period between 10.00 am and 6.00 pm Monday to Saturday in any part of a restricted road specified in Part VIII of Schedule 2 to this Order.

3. In Article 36 sub article (b) shall be deleted and the following sub article shall be inserted:

(b) no vehicle shall wait during the period:-

- (i) between 8.00 am and 7.30 pm on any day so far as any such period falls within the restricted hours in any part of a restricted road specified in Part VI of Schedule 2 to this Order
- (ii) between 10.00 am and 6.00 pm Monday to Saturday so far as any such period falls within the restricted hours in any part of a restricted road specified in Part VIII of Schedule 2 to this Order

for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle; and

4. In SCHEDULE 2 PART II after the reference to CENTRE ROW the following reference shall be inserted:

CHAMBERLAIN SQUARE Whole Area

5. In SCHEDULE 2 PART II after the reference to COMMUNICATION ROW the following reference shall be inserted:

CONGREVE PASSAGE Both sides, whole length

6. In SCHEDULE 2 PART II the reference to Victoria Square shall be deleted and the following reference shall be inserted:

VICTORIA SQUARE Whole Area

7. Following SCHEDULE 2 PART VII the following schedule shall be inserted:

VICTORIA SQUARE Whole Area

CHAMBERLAIN SQUARE Whole Area

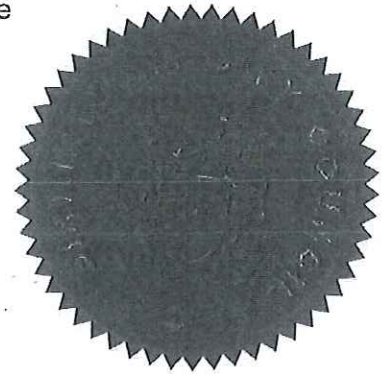
