THE COUNTY COUNCIL OF SOMERSET in exercise of its powers under Sections 1 (1) and (2) and 2 (1) to (3) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act HEREBY MAKES THE FOLLOWING ORDER:-

1. IN this Order "maximum gross weight" has the same meaning as in the Traffic Signs Regulations and General Directions 1981; and "bus" has the same meaning as in the Road Vehicles (Construction and Use) Regulations 1986.
2. SAVE as provided in Article 3 to this order, no person shall, except upon the direction or with the permission of a Police constable in uniform, or a Traffic Warden, cause any vehicle, the maximum gross weight of which exceeds 7.5 tonnes to proceed in the length of road specified in the Schedule to this Order.
3. NOTHING in Article 2 of this Order shall apply so as to prevent any person from causing any vehicle to proceed in the length of road referred to in that Article if the vehicle is:-
  - a) being used for the conveyance of goods or merchandise to or from any premises situated on or adjacent to that length of road or accessible only from that length of road;
  - b) being used in connection with any building operation or demolition in or adjacent to that length of road, the removal of any obstruction to traffic in that length of road, the maintenance, improvement or reconstruction of that length of road, or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act, 1878;
  - c) being used by or on behalf of a local authority or statutory undertaker summoned by an emergency call; or
  - d) a bus.

4. THIS Order shall come into operation on the fifteenth day of May 1995 and may be cited as the County Council of Somerset (Magdalene Street, High Street, Lambrook Strook, Silver Street & Chilkwel Street, Glastonbury) (Weight Restriction) Order 1995.
