HEADS OF TERMS REGARDING TRIANGLE FIELD USE AS ALLOTMENTS

- 1) The area of land to be used as allotments as shown outlined red on the attached plan.
- 2) The land to be used as allotment gardens to be managed by Hungerford Town Council Allotment Committee in accordance with any legislation governing the use of land for allotments.
- 3) All services required i.e. water, drainage, electricity (if required) to be provided and maintained at the expense of the Town Council.
- 4) Any planning or statutory consents required for the use of the land or provision of access or temporary buildings to be obtained by the Town Council.
- 5) The Town Council to hold Third Party liability insurance against any claims that may arise on the land and to indemnify the District Council as owner.
- 6) The site to be fenced off from the Triangle Field by chain link fencing no higher than 1.8 metres or such other type of fencing as the council may approve.
- 7) West Berkshire District Council to approve the licence agreement that is to be used by the Town Council in respect of licencing the allotments.
- At the end of the term however occasioned, to reinstate the allotments back to playing field use if requested to do so by West Berkshire District Council and remove all fencing, structures and lay the land out to a grass surface to the satisfaction of the District Council.
- 9) The Town Council to satisfy itself that there are no pipes, cables or other services that will be disrupted by cultivation of this area of land.
- 10) The Town Council to erect a notice board giving contact details in respect of the allotments in a conspicuous position on the site.
- 11) Each side to bear its own costs in preparing the necessary documentation.
- With regard to the proposed use of land to the south of the car park, there is currently a planting scheme attached to the Rugby Club planning application 05/02564, and this condition will need to be relaxed by application to the planning dept and the use of land changed to that of allotments.
- Access to the proposed area to the south is via the car park, which is shown in the proposed underlease to the Rugby Club as being within their demise, and arrangements for allotment holders to have access over the car park will need to be agreed with the Rugby Club.

Annette.

I have now inspected the Triangle Field and the location of the area for allotments does not appear to interfere with the playing field and the NW perimeter isrough shrub/bush type undergrowth and not mature trees so there will not be an issue regarding any tree removal.

With regard to the land to the south adjoining the car park hammer head, this is currently an open area and would be suitable for allotments but the Town Council will need to apply to the Planning dept for the relaxation of the planning condition attached to the rugby club consent in respect of landscaping as this area is shown as planted.

Additionally the Town Council will need to come to some arrangement with the rugby club regarding access over the car park since it seems that the TC Underlease includes the car park within the demise and there is now a gate across the car park entrance.

Hungerford Town Council has approached the council with a request that part of the Triangle Field around the eastern periphery be used for allotments as the Town Council currently has some 100 requests for allotments which it cannot fulfill.

The use will not interfere with the current use of the field as a rugby or football pitch and the Town Council are to contact the adjoining houses as a courtesy to address any concerns they may have.

Thanks for your memo dated 12th December 2008.

I note in principle you have no objection to the proposal regarding the allotments.

One of the intial issues to be addressed is planning. I think Paul Jackson confirmed planning permission would not be required, unless there were buildings erected on the land. However, planning permission may be required for vehicular access. I suggest you contact Paul Jackson direct for further confirmation on this point.

I suggest the Heads of Terms refer to a surrender rather than a Deed of Variation as there will be major variations to the terms of the lease. In those circumstances a surrender is appropriate.

The Heads of Terms should clearly reflect the works you require to be undertaken and the transaction should also be subject to a resolution by the Parish Council, subject to delegated authority from the District Council, subject to any planning permission (which may be required being obtained) and also subject to the District Council approving any agreements\licences granted to allotment holders.

I also suggest you contact Kathy Warden in Countryside & Environment to inform her of the proposals.

Under the terms of the lease, it is possible to request the land revert to a previous or different use. However, this would also be dictated by the planning regime. You may wish to discuss this further with Paul Jackson. I suggest the Council retains the freehold reversion (rather than an outright disposal).

Colin, I suggest in the first instance you prepare draft Heads of Terms. I will then approve the Heads of Terms before they are issued to the Parish Council.

HUNGERFORD ALLOTMENTS

I have received the attached letter from Hungerford Town Council requesting that WBDC permit them to change the use of part of the Triangle Field shown hatched red on the attached plan to that of allotments.

As you are aware the Town Council leases the field from West Berkshire District Council under a 50 years lease from 10 September 1992 at a nominal rental of £5 p.a. the lease containing an option for the Town Council to extend their lease for a further 50 years on the same terms.

The lease does prohibit subletting or parting with possession and currently the uses are prescribed to sporting activities and no buildings are to be erected except an extension to the pavilion.

However, clearly the Council can vary the lease if it so chooses, and in principle given that WBDC may not get possession of the field for over 80 years, and that the Town Council are presumably best placed to assess the need in the locality, I would have no objection to the proposal.

There are specific issues the Town Council will need to address such as fencing in the allotment, providing vehicular access to the individual plots and possibly laying on some sort of metered water supply. Additionally the permission to site temporary sheds on the allotments may have to be agreed.

I believe that the users of the allotments are usually given a yearly licence, and Newbury Town Council lets plots of around 1,000 sq. ft at £25p.a. so there is no money to be made by the Town Council if it has to fence the site and provide water and manage the allotment holders.

In total the Town Council may be likely to obtain total rents of £500 p.a. if it can get around 20 allotments but if an access drive has to be left vacant this could reduce the income.

One issue however that I am not clear on is whether, if the land is given over to allotments it is lost to this use forever and whether at the end of the lease the land could if required, revert back to WBDC and open space.

Whether any agreement is dealt with as a Deed of Variation or we agree to take a Surrender of the land to be allotments and grant a new lease will need to be discussed, but if the land once given over to allotments cannot be reclaimed by WBDC, consideration may need to be given to whether an outright disposal may be appropriate.

I would welcome any thoughts you may have on the subject prior to me responding to the Town Council.



Mr Harries was under the impression this was not required and they just needed to notify the District Council. I said this was not the case.

I said if it was likely planning permission was to be granted, the District Council would also need to agree to the proposal in its capacity as the landowner. The Town Council would also need to agree to the variation to the lease as it was currently used for recreational purposes.

I suggested Peter Harries contact Paul Jackson to discuss the question of planning and use as allotments.
