Universal Jobmatch – sharing good practice.

Following recent discussions and feedback around Business Readiness, we have pulled together a number of products and practices to support go live preparations.

WET have asked that these are shared as soon as possible. They have been captured so that you can use them flexibly, alongside the project and OED material already supplied to finalise your local arrangements and provide yourselves with the relevant assurances that you have everything in place for a successful go live. If you have already devised your own plans, for example, there is no expectation of having to use one of these formats.

WET specifically do not want a ticklist assurance rather that the products and in particular the Operational Assurance document are used flexibly.

Day 1 Access

A further document clarifying what services / activities will be available on day 1 will be with you very shortly to support the guidance already issued. You will want to consider how best to get all your staff to set their password on day 1. That may be blocking out their diary, managing it through day 1 or week 1 via team access and timeslots, or another method which works for your area.
