Thank you for your email of 31 January 2019 requesting the following information:

"I would like to make an enquiry into some land/property that may belong to you.

The land/property in question is located in High Street, Figledean, Wiltshire SP4 just off the A345 going towards Netheravon Wiltshire.

Description:

An old unused building with out buildings at the rear, land which could be used as parking space.

I have just started a business in Deliveries and car collection delivery and also breakdown recovery.

I am looking for somewhere to store 2 vans and 2 trailers, me and my wife are looking to move in the same area where this land/property is located.

I would like to know if this land/property is available to rent or for sale as it would be perfect for my business."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that information in scope of your request is held.

The information you have requested can be found below:

The land in question is owned by the MOD however, the land is currently held under an agricultural holdings tenancy. At present there are no plans to dispose of this land.
