Thank you for your request for information under the Freedom of Information Act, received on 27 February 2019, reference number **FOI 19084**. I can confirm that the Aneurin Bevan University Health Board has completed a search of its records and has established that it does hold information falling within the confines of your request. Please find below the response to your request.

I would like to request how many patients were treated by the two urology consultants in the 26 week period. How many patients are being treated by other consultants?

Please find below the information you have requested for the period 13 August 2018 to 3 March 2019 (the latest 26 week period available). It is important to note that some major surgery would take a whole day, whilst in day cases up to eight patients can be seen in a day. In addition, waiting times and treatment times can also depend on the sub-specialty of the consultant.

Information for the two consultants with waiting times of 26 weeks or less:

Consultant A carried out 113 operations which were mainly major inpatient cancer work.

Consultant F carried out 169 operations which were a combination of inpatient and day case work.

Information for the remaining consultants is provided below:

Consultant B carried out 150 operations and also has a robotic operating list at the University Hospital of Wales, Cardiff.

Consultant C carried out 170 operations which were mainly major inpatient cancer work.

Consultant D carried out 117 operations which were mainly major inpatient cancer work. This consultant also has a separate robotic operating list at the University Hospital of Wales, Cardiff.

Consultant E carried out 180 operations which were a combination of inpatient and day cases.

Consultant G carried out 661 operations which were a combination of day cases and flexible cystoscopies.

I hope that you find this information useful. If you are not satisfied that all of the information you have requested has been provided, or because of the way your request has been handled, you have the right to request a review. This would be looked into in accordance with the Health Board's Appeals Procedure. 
