## 2) For each site listed, please provide a value for the cost of the site to the health board?

Under section 17 of FOISA I am required to notify you that the information you request is not held by NHSGGC. We can advise that the costs for these sites are being covered by the constituent Local Authorities within NHSGGC (with support from the Scottish Government), with the exception of the Louisa Jordan which is directly funded by Scottish Government. There is therefore no cost to the health board.

If following a review you remain dissatisfied with the outcome, you have the right to ask for advice, assistance or to make a formal appeal in writing to the Scottish Information Commissioner within six months of receiving the outcome of a review. If following appeal to the Scottish Information Commissioner you still remain dissatisfied with the outcome, you have a right of appeal to the Court of Session on a point of law against the decision of the Scottish Information Commissioner.
