We have considered your request under the Freedom of Information Act 2000 (**FOIA**) and, where relevant, the Environmental Information Regulations 2004 (**EIR**).



Of the licences you have listed, changes have only been made to eleven (as listed below) where the OGA has extended the drill of drop decision date from two years to the end of initial term.

In each case, in agreeing to the extension, the OGA wrote to each company setting out the changes as follows:

"The model clauses which apply are set out in Schedule 2 to The Petroleum Licensing (Exploration and Production) (Landward Areas) Regulations 2014 (S.I. 1686/2014).

In particular, clause 4 of the Licence sets out:

Determination of Licence during Initial Term where a Drill-or-Drop Period is specified

4. (1) Where a Drill-or-Drop Period is specified, this licence shall, unless the Minister [the OGA] in his discretion decides otherwise, automatically



cease and determine on the expiry of that period in the event of failure by the Licensee before the expiry of that period to-

- (a) take the actions that are described in Part 1 of the Work Programme; and
- (b) undertake to complete on or before the expiry of the Initial Term the work described in Part 2 of the Work Programme.
- (2) In this clause, "Drill-or-Drop Period" means the period (if any) specified as such in Schedule 5 to this Licence.

[Pursuant to Schedule 5, the Drill-or-Drop Period will expire on 20 July 2018 being the period of **two years** beginning with the Start Date (21 July 2016).]

In accordance with clause 4.1 of the Licence the OGA hereby exercise its discretion such that the Drill-or-Drop Period is now the period of **five years** beginning from the Start Date (i.e. by the end of the Initial Term).

I would like to point out that, among other things, the Licensee is obliged to complete the work programme before the expiry of the Initial Term (as provided for under clause 5(1)(b) of the Licence)."

This concludes the OGA's handling of your request.

Appeals Procedure

If you are unhappy with the way the OGA has handled your request, you may request an internal review.
