Your email dated 3rd February 2017 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

I would like to make a freedom of information request for any information held in relation to ex MOD vehicles with the following VRN/registration:

VN 31 AA - Land Rover

BC 38 AB - Pinzgauer

Also any parts lists, user & maintenance manuals relating to Pinzgauer 716MK TUM(HD) 4x4 FFR

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. Unfortunately, following the closure of MERLIN it is only possible to retrieve information held on the archived version of the database, which is attached.

This information supplied to you continues to be protected by copyright. You are free to use it for your own purposes, including for private study and non-commercial research, and for any other purpose authorised by an exception in current copyright law. Documents (except photographs) can be also used in the UK without requiring permission for the purposes of news reporting. Any other reuse, for example commercial publication, would require the permission of the copyright holder.

Most documents supplied will have been produced within government and will be Crown Copyright. For information about re-using Crown Copyright see the Office of Public Sector Information website at www.opsi.gov.uk. The copyright in some documents may rest with a third party. For information about obtaining permission from a third party see the Intellectual Property Office's website at www.ipo.gov.

In respect of parts lists, user and maintenance manuals, the information could not be provided without incurring a disproportionate cost. The information required for your Pinzgauer 716MK TUM(HD) 4x4 FFR would need to be extracted from a suite of Army Engineering Support Publications and Illustrated Parts Catalogues consisting of thousands of pages.

Section 16 of the FOI Act requires public authorities to assist requesters where it is reasonable to do so. I can advise that Pinzgauer manuals can be purchased through greenmachinesurplus website at: <http://www.greenmachinesurplus.com/pinzgauer-203-c.asp>

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
