Thank you for your email of 10 August 2020, requesting the following information:

Could you please supply any information about vehicle reg KA 26 AA such as its military service history or uses?

Your request has been handled in accordance with the Freedom of Information (FOI) Act 2000.

A search of Ministry of Defence (MOD) records has now been completed and I can confirm that information about the service history of this vehicle is held and provided in the attached Annexes:

Annex A - Vehicle history
Annex B - Inspections history
Annex C - Service history
Annex D - Modifications history
Annex E - Faults history
Annex F - Usage history

Some information about your vehicle has previously been published and Section 21(1) of the FOI Act provides that information is exempt if it is reasonably available by other means. The Merlin archive was released as part of a previous FOI request and can be accessed at the Government publications website, at the following:

Under Section 16 (Advice and Assistance) of the FOI Act, I can advise you that some of the information in the attached Annexes is best viewed by using the zoom feature within the relevant software package on your computer. Also, the Merlin database in the above link is split into seven spreadsheets. The first has a list of vehicles, while sheets two through seven include the service histories. To search for a vehicle, you must press Ctrl + F on your computer keyboard, then select 'Options' and then select 'Workbook' from the 'Within' drop down list. Information relevant to your request can be found by typing the vehicle registration number and pressing 'enter'.

You may wish to note that when the Merlin database was archived into its current format some data may have been lost or corrupted. You should, therefore, be cautious that some of the data may be inaccurate.
