Your email dated 18<sup>th</sup> April 2017 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

"could you please supply any details held in relation to vehicle ERM: 16 HG 82"

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. Unfortunately, following the closure of MERLIN it is only possible to retrieve information held on the archived version of the database, which is attached.

This information supplied to you continues to be protected by copyright. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
