Freedom of Information Request - RFI20220341

Thank you for your request to the BBC of 17 February 2022 seeking the following information under the Freedom of Information Act 2000 ('the Act'):

- I. What editorial control does Bill Gates(and/or the Gates Foundation) have over the BBC (or one of their subsidiaries)?
- 2. How much money has Bill Gates (and/or the Gates Foundation) paid to the BBC (or one of their subsidiaries) in each of the last 20 years? Please provide figures yearly.
- 3. What is the official reason for Bill Gates's (and/or the Gates Foundation) payments to the BBC (or one of their subsidiaries)?
- 4. Do Bill Gates's (and/or the Gates Foundation) payments to the BBC (or one of their subsidiaries) give him any influence? If so please describe.

In response to Parts I and 4 of your request, neither Bill Gates, nor the Gates Foundation, have any editorial control, or influence of any nature, over the BBC or its output.

With regards to Parts 2 and 3 of your request, please be advised that the BBC is funded through the licence fee and may only take funding for content from limited exceptions that conform to Clause 49 of the BBC Framework Agreement. We can confirm that it does not receive income from Bill Gates or his associated companies.

As set out in section 6(1)(b)(ii) of the Act, our subsidiaries (including BBC Studioworks Limited, UKTV, BBC Global News Ltd and BBC Studios Ltd), as well as the charities BBC Media Action and BBC Children in Need, are not subject to the Act. Therefore information regarding their activities is also not subject to the Act.

However, we can confirm that the Gates Foundation have provided funding to BBC Media Action. BBC Media Action is a company limited by guarantee and a registered charity. As an independent charity, it receives funding from institutions, foundations, corporate and individual donors to carry out life-saving and life-changing work. It does not receive any Licence Fee funding. BBC Media Action's accounts are publicly available at Companies House, the Charities Commission and on our website. Appeal Rights

If you are not satisfied that we have complied with the Act in responding to your request, you have the right to an internal review by a BBC senior manager or legal adviser. A request for an internal review must be made within 40 working days of receiving the BBC's response to your original request.
