We were last in touch in November around matters to do with the Wilson Wellbeing Steering Group meeting on 30th October 2019.

Since then there has been no public information released about the Wilson that I am aware of, and as far as I am aware the Welbeing Steering Group has not met since 30 October 2019. The minute of that meeting are still not in the public domain.

Now that Merton CCG is merging into a SW London wide CCG, I am concerned about where to go to find information, and how to know who to contact in relation to different aspects of the project both around the community side of things and around progress on funding and site development.

From where I am sitting now the whole Wilson programme is completely silent.

The new six-borough CCG does not seem to have a web site yet - and there seems to be no meetings schedule or place to go to find meeting papers.

So - I wonder if you can help me with several questions?

Where will I find the minutes of and agendas for meetings of the Wilson Wellbeing Steering Group?

Has the Wilson Wellbeing Steering Group met since 30th October?

When is the Wilson Wellbeing Steering Group's next meeting to take place?

Who is liaising with MVSC on the Wilson related web pages? (These are, as I have said to you before - very hidden within the web site, and rather confused once you get to them. More transparency, greater visibility and greater clarity would be welcomed.)

Where will I find the web site of the new South West London CCG?

Where on that web site will I find meeting papers?

Where will I find CCG meeting papers and other information relating to the Wilson development going forwards?
